SPECIAL FALL ACTION: ASK THEM WHERE THEY STAND!

Election season is the perfect time to ask your elected representatives where they stand on medical aid in dying. Simply call their office and ask the question! Whatever their position, it will help raise the profile of the issue.

- Find your representatives on your state legislature's website. Simply call the number and explain that you are inquiring about the elected official's position on medical aid in dying (you can reference California's recent law).
- 2. Click the box on the right to send an e-mail to your elected officials asking for their support!


